GENERALLY THIS EMAIL TO: All personnel in all universities and colleges in the United States and the world. This particular email is addressed to the personnel of the University of New Mexico.

The General Statement of Purpose of this email: There is no university in the world human society that offers a curriculum that leads to a BA, MA, PhD in "Peace Studies" therefore I am trying to create one. I have no competition in this effort. I have no peers in this effort.

The Specific Statement of Purpose of this email: I, Dr John WorldPeace JD, have accumulated the material and significant personal experiences, research, documentation and articles and commentary related to a Teach Peace curriculum. 40,000 pages on JohnWorldPeace.com. I am now trying to find a university interested in becoming the hub of this project: the hub to which all the universities in the world will connect.

As I work through contacting every university in the USA and then the world, I am going to keep a record of the response I get from every university. The effort to create a Teach Peace curriculum is a Teach Peace subject in and of itself. This record will definitively relate the obstacles to Teach Peace in universities. This is a secular endeavor but it definitely has a significant religious/spiritual aspect.

Note: As a career salesman for my personal businesses, my experience was that every potential customer contact resulted in information to refine my approach. As I gather unique information, university to university, I will adjust my "sale pitch" accordingly to be more clear and effective..

The foundational issues of Peace are on my website: JohnWorldPeace.com; which contains 42,000 pages. The entire site is related to increasing the peace in the world human society, locally and globally, which is referenced in other pdf documents attached to this website.

Specific Objective of This Document: To relate my personal experience in approaching the University of New Mexico in Albuquerque, for the purpose of setting up a Teach Peace curriculum. My experience with UNM is what I am expecting to potentially be

both the same and unique with other universities. By emailing all the universities in the world, starting with the United States, starting with the University of New Mexico, I want to identify the firewalls that I am going to encounter in finding a home for my Teach Peace curriculum. I have no desire to maintain or to pay someone to maintain ego centric possessions. Virtually every dollar that comes into this project will be spent to propagate and expand this project. In time all my art and all my books will be owned by this project. Virtually every object I possess is an object with no intrinsic value that had/has some spiritual inspiration for me. The only thing one takes out of one's life back into the infinite immortal spiritual dreamscape is one's experiences. All the rest is really just an illusion/delusion within the finite mortal earth dreamscape

DR JOHN WORLDPEACE' PERSONAL EXPERIENCE IN SPEAKING WITH THE UNIVERSITY OF NEW MEXICO ABOUT SETTING UP A TEACH PEACE CURRICULUM.

First, in April 1988, after my first divorce and three weeks before I was going to turn 40, I legally, changed my name to John WorldPeace. Almost immediately within a week I began to write a book on peace titled The Common Denominators of Peace and Peaceful Coexistence. In 1993, I sent a query to Harper San Francisco about publishing my book. The CEO was interested but after several months of communication, the CEO said one of his VPs killed the project by saying "That books on Peace do not sell." With some books and ideas you have to create the market.

I had changed the book title to "The Book of Peace" at the CEO's suggestion. I made two other significant marketing attempts after having 165 books printed. However, I was simply too busy with my businesses to pursue any marketing and the price charged by those who did publish and market books was too much in my opinion. I had started insurance, accounting, tax and law businesses and in 2003 began a web design business. All successful. But these businesses, plus a family, and then a divorce in 1987 left no time for marketing my "Book of Peace".

Second, in 2017 I made my first effort to set up a Teach Peace curriculum. https://worldpeaceteachingpeace.com/DrJohnWorldPeaceJdTeachPeaceCurriculum.as
p. This is the snail-mail inquiry I made directly to about 250 Presidents/Chancellors of various universities in the USA regarding setting up a Teach Peace curriculum. No response

Third, after an extensive expansion of my Teach Peace curriculum, I realized I needed to go to UNM (University of New Mexico) in person and see what it was going to take to accomplish my marketing goala. Correspondence was not going to work. Like in my other businesses, I initially needed face to face input and that would not come from correspondence.

Having moved from Texas to Albuquerque, New Mexico in 2011, it made sense to me that this is where I needed to begin to find a university to Teach Peace.

On August 14, this year, I went to UNM to find out who I needed to talk to about initiating a Teach Peace curriculum. I went to the main employment office at University and Lomas. I was buzzed in and talked to a woman who asked me what I was trying to accomplish She told me that I needed to go to Shoales Hall to see the woman who handled new courses. I went to the second floor Shoales Hall and talked to 3 women who asked me more details and said that I needed to see Ms? Cheek but that she was not there and would not be back until Friday the 16th because she was on vacation. I was also told that school started the next Monday the 19th. I told them I would not come back until the week after school started to avoid the confusion of the first week of school.

This woman also said that I should go over to the political science department where the 1st Court of Appeals and the Law School were located. I went over there and there were three women just finishing lunch and we talked about 20 minutes. Very cordial. One gave me a map of the campus and showed me where things were. I said it was too hot to walk around campus and I would have to come back.

I went back on the 28th and went again to Shoales Hall. The secretary got up from her desk and took me down the end of the hall and told about 8 women standing there I was looking for Ms? Cheek. They all pointed to his woman about 65. She indicated I follower her and on the way to an office she said she only had 3 minutes that she had an appointment. This was not her office. Her office was down the hall where I had been on the 14th. We sat down at a small table. She told me twice again she only had three minutes.

I took out a 21 page document I had typed up regarding setting up a Teach Peace curriculum and a copy of a letter I had sent to Presidents of universities back in 2017. (Se above link). I put them on the table and pushed them to the center. She did not make any effort to touch them. I told her I wanted to discuss a Teach Peace curriculum. I told her I was told she was the one I was told was in charge of being the first to review new classes. She said she was. I have no experience with universities except ten years as a student. I never has any issues that required me to see anyone in administration.

She said they already had a couple of classes on peace. I said I was talking about a curriculum for a BA, MA, PhD. She interrupted me and said they had tried to set up a Teach Peace studies that did not work. I said I would expect that. There are no experts in that field. She said some other similar things and each time I said, "Been there done that". I then said I had a Peace website with 42,000 pages on it. She looked a bit shocked. But said nothing.

Then she said in a very short statement that a course like that would by state law have to be headed up by a PhD on staff. She was rushing so I did not ask her how they would find such a person since there was no such PhD curriculum at any university in the world.

Then she got up and said she had an appointment. Then she said I could look into some peace clubs on campus. I said again "Been there done that." I was not given time to say it was all in the documents I gave her.

She was right in my face and I said you don't have a Peace Studies that leads to a BA, MA, PhD do you and she again looked shocked (that I was still challenging her) and paused and said no.

She had not looked or even touched what I had given her. So in 3 minutes and without looking at what I gave her and without asking me any questions about my experience and qualifications she had made a decision that I was wasting her time.

As far as she was concerned the time I had was up and there was no point in me returning. No statement that she intended to look at what I gave her.

When I walked out into the large hallway there were about 8 campus cops there. I thought something was going on. A cop got in my way without saying anything. I asked if he wanted to talk to me.

He asked me what I was doing there and I said I was told to come and talk to this Cheek woman about starting a teach peach curriculum.

I asked what this was about. And he said someone said I had a gun. I said I didn't. And I took off my pack which had 12 of my 150 books in it and put it on the floor and he examined it. Then without being asked, I raised my hands and told him to search me if he wanted. He got behind me and patted me down and indicated to the other cops I had no gun.

Then he asked if the "Dr John WorldPeace JD" embroidered on my shirt pocket was my name and I said yes. It did not make sense to him so he asked for my drivers license and I gave it to him. He glanced at it and gave it to a cop who seemed to be the supervisor who took it and ran it and a few minutes later gave it back to the cop in front of me and said I was clear. Then he asked me if I was a vet because I had on one of vet caps. I said yes, Army Sgt 70-72..

Then he said I could not carry a gun on campus. And I said I have no gun. He said it was against the law to bring a gun on campus. And I repeated that I had no gun but New Mexico had an open carry law and I did take my derringer 95% of where I went because I was 76 and looked like a target and that Albuquerque was a dangerous place and I had been confronted about 3 times. That is also a reason I wore my Vet cap.

I also told him that there were signs on the door to the bank and the VA that said guns were prohibited. And I told him that I saw no signs anywhere on campus, at the entrances or on the buildings or elsewhere that guns were prohibited. He made no comment. Nor did he comment when I brought it up two or three more times.

I practiced law in Texas for 20 years and I knew generally you need to give people notice on issues regarding guns. But I did not say that.

Then he told me that I could not come into that building without an appointment since I was not a student or employee of the University. I again said I had seen no signs on the building or anywhere else that entrance to Shoales Hall was restricted. Again he did not respond.

I also said that I was not told any of this by any of the three places I had been 14 days prior. Again no comment.

Then after about 20 minutes of conversation, he said he would have to escort me off campus. I did not bother to ask him why. He did say several times thanks for my cooperation.

So he says where is your car. I said I am on a motorcycle and I was turned around and did not know where it was. So we walked around the building and I could still not get oriented. It was only my second time on campus. After 13 years in Albuquerque, I had only been on campus maybe twice just riding around and that was 5-7 years prior and only for 10 minutes.

We walked around the building and I saw the church where I had parked and I started moving in that direction. We got about 100 yards away and he stopped me and another cop drove up. This cop got out of his car with some papers and told me that I could never come back on campus. I said "Never?" and he said 72 hours that he needed time to figure out what was going on.

I said nothing was going on except I was trying to see the Cheek woman. He gave me a document that I had to sign. There is a copy at the bottom of the Teach Peace page. It is yellow.

Then I went to my motorcycle and got ready to leave. They had a cop in a car to make sure I drove off campus which was about 100 yards to the main street.

I decided not to ask any questions but that I would write this letter and send it to every email address I could find on the UNM campus which was about 550. I have had a computer since 1980 and a web design business so I knew how to harvest emails on any business.

I decided that being confronted over 38 years since I changed my name, that it would do no good to challenge anyone with negative attitudes about peace.

I wanted to write this document because I wanted to make a point of a real time situation with people reacting to someone named WorldPeace. And in particular the reaction in a university environment with a lot of authority figures. So this will be a cover letter to all the universities I contact in pursuit of my Teach Peace objectives. I fully understand the resistance people have to Peace and WorldPeace. So, UNM has become an example of that negative attitude toward peace.

The fact is that people talk about wanting peace but they instinctively hate peace. The reason is very simple. People hate change more than they hate peace. And increasing the peace means change and the knee-jerk attitude is "not interested".

And Christians tell me no peace until Jesus comes. I ask them if they object if I try to increase the peace while we wait for Jesus. The truth is that for Jesus to create a perfect peace he will have to turn everyone to stone.
